Tyson Foods, Inc. Group Health Plan (the Plan) is a self-funded ERISA plan. Once you and your designated Authorized Appeal Representative have each signed this form and returned it to your claims administrator at the address listed below, please understand that by signing and submitting this form, you have authorized the Authorized Appeal Representative to:

1. Exercise your appeal rights under the Plan.
2. Access all of your medical information and claims for healthcare benefits under the Plan, to the extent that any of them are relevant to your appeal.
3. Receive communication directly from BlueAdvantage, the claim administrator, with regard to your appeal, as well as all related information such as claims, medical records, explanations of benefits, telephone calls, correspondence, your address, telephone numbers, Social Security number and Plan identification numbers, premium payments or other Plan eligibility data.
4. Receive communication directly from the Plan, via BlueAdvantage, about your Plan's decision regarding your appeal, as well as other information related to the appeal.

If you wish to designate an appeal representative, please complete parts A through D of this form and send it to the claim administrator at the address shown at the bottom of this form.
